**MANAGEMENT’S DISCUSSION AND ANALYSIS OF FINANCIAL CONDITION AND**  
**RESULTS OF OPERATIONS**

**INTRODUCTION**

The following management discussion and analysis of the financial condition and results of operations (“MD&A”) of Many Bright Ideas Technologies Inc (Formerly Med BioGene Inc.). (the “Company” or “MBITI” (Formerly “MBI”) has been prepared by management, in accordance with the requirements of National Instrument of 51-102 as of November 25, 2022 and should be read in conjunction with the unaudited condensed consolidated interim financial statements for the nine-months period ended September 30, 2022 and the related notes contained therein which have been prepared under International Financial Reporting Standards (“IFRS”) as issued by the International Accounting Standards Board (“IASB”). The following should also be read in conjunction with the annual audited consolidated financial statements and the related MD&A for the year ended December 31, 2021, and all other disclosure documents of the Company. The information provided in this document is not intended to be a comprehensive review of all matters and developments concerning the Company. All financial information in this MD&A related to 2022 and 2021 has been prepared in accordance with IFRS and all dollar amounts are quoted in US dollars, the reporting currency of the Company, unless noted otherwise.

**GOING CONCERN UNCERTAINTY**

It is believed that MBITI’s ability to continue as a going concern and achieve its business objectives is dependent upon obtaining significant additional financing. On November 28, 2016, MBITI announced a

termination and settlement of the prior commercialization and licensing agreement (as amended, the “Commercialization Agreement”) with Helomics™ Corporation. This terminates the original licensing agreement put in place in 2011 by prior MBITI management and relieves MBITI of all the encumbrances associated with this agreement.

Subsequent to this termination, a realistic assessment of the potential value of the Company’s intellectual property concluded that it was negligible due to the development of less invasive, and more cost effective, prognostic procedures.

As a result MBITI continues to operate in as lean a manner as possible to conserve cash reserves while exploring other business opportunities related to non-medical technologies. The Company anticipates that it will develop other licensing partners for new technologies in order to maintain operations. Management’s intention is to implement much simpler licensing agreements in the future than were previously in place, with stronger mechanisms to ensure royalty streams begin sooner and are less cluttered by encumbrances and other setoffs. Such relationships will also depend on the willingness of the new licensing partners to entertain such terms in the final agreement.

If MBITI needs to raise additional funds through the sale of equity or debt securities or the merger or sale of MBITI, the sale of such additional equity and debt securities may result in dilution to MBITI shareholders, or it may not be available in amounts or on terms acceptable to MBITI. If additional capital is required and not obtained, MBITI may be forced to cease operations.

## **BUSINESS**

MBITI was initially a life science company focused on commercializing a prognostic genomic-based test for non-small-cell lung cancer (“NSCLC”). This intellectual property was believed to hold promise, but was subsequently found to not be cost effective. Consequently, MBITI is now focusing on the commercialization of technologies in a number of industrial sectors which offer much lower entry costs, and broader general acceptance in other markets.

## **CHANGE OF NAME**

Pursuant to the meeting of the directors held on May 10, 2022 and a directors resolution dated the same day, the name of the Company was changed from Med BioGene Inc. to Many Bright Ideas Technologies Inc.

## **RESULTS OF OPERATIONS**

### **For the nine months ended September 30, 2022 and 2021**

Including certain expenses accrued but not incurred, as further described below, MBITI recorded a net loss of \$49,000 (\$0.00 per share) for the nine months ended September 30, 2022 compared to net loss of \$49,825 (\$0.00 per share) for the nine months ended September 30, 2021.

The Company did not generate any revenue during the periods ended September 30, 2022 and 2021. The results are consistent with management’s expectations for the periods.

## Expenses

General and administrative expenses consist of public company costs, facilities and office operations expenses and professional fees.

General and administrative expenses were \$53,126 for the nine months ended September 30, 2022 compared to \$50,396 for the nine months ended September 30, 2021. The increase in general and administrative expenses for the nine months ended September 30, 2022 compared to the nine months ended, September 30, 2021 is primarily attributable to the increase in public company costs incurred in the current year.

MBITI does not utilize derivative instruments. While MBITI does incur expenses denominated in U.S. dollars, MBITI purchases foreign currency as required on the spot market. At present, management believes that the timing and size of such U.S. dollar transactions does not warrant active hedging; however, as the business develops in the future, some limited hedging activity may be undertaken.

MBITI invests its cash reserves in liquid and highly secure investments. MBITI does not hold any investments in asset backed commercial paper. Presently all of MBITI's cash reserves are held on deposit with a major Canadian chartered bank. MBITI does not guarantee any third party obligations and has not entered into any off-balance sheet arrangements.

## Other comprehensive income (loss)

Other comprehensive income (loss) results from the foreign exchange translation adjustments in MBITI's condensed consolidated interim financial statements resulting from exchange rate differences between its functional currency, which is Canadian dollars, and its reporting currency, which is U.S. dollars.

### CONTRACTUAL OBLIGATIONS

With the cessation of attempts to commercialize the company's medical intellectual property, MBITI has no contractual obligations.

On November 28, 2016, the Company and Helomics™ signed a settlement agreement which terminated the Commercialization Agreement dated April 15, 2011. Helomics™ paid a lump sum amount to the Company as a part of the settlement agreement which has been included as other income in the statement of comprehensive income (loss) for the year ended December 31, 2016. All other debts, setoffs, and other residual obligations from MBITI back to Helomics™ were waived in full as a result of the settlement agreement.

### RELATED PARTY TRANSACTIONS

During the period ended September 30, 2022, the Company:

- (i) paid or accrued \$nil (2021 – \$nil) and \$7,018 (2021 – \$7,193) for accounting fees to a firm where a director of the Company is a partner and to an officer of the Company respectively;

Related party transactions are reflected as part of general and administrative expense. Amounts owing to these related parties (including former management and directors of the Company) as at September 30, 2022 were \$17,749 (December 31, 2021 –\$59,379). These amounts are non-interest bearing and due on demand.

## **NEW ACCOUNTING STANDARDS ADOPTED EFFECTIVE JANUARY 1, 2022**

The Company was not required to adopt any new accounting standards during the period ended September 30, 2022.

### **LIQUIDITY AND CAPITAL RESOURCES**

At September 30, 2022, MBITI had cash totalling \$1,532 and a working capital deficiency of \$55,651, compared to cash of \$9,193 and a working capital deficiency of \$81,224 at December 31, 2021.

Cash used in operating activities was \$7,850 for the nine months ended September 30, 2022 compared to cash used in operating activities was \$135,804 for the nine months ended September 30, 2021. The cash used in operating activities consisted mainly of professional fees, payments to third parties and company operating costs.

### **FINANCIAL INSTRUMENTS AND FINANCIAL RISK MANAGEMENT**

#### Capital disclosure

The Company considers share capital, warrants, and equity reserves as capital. The Company's objectives when managing its capital structure are to provide sufficient capital to advance the commercialization of its products, meet the Company's obligations as they come due, and provide for the potential acquisition of additional intellectual property rights related to products within the Company's strategic plans.

The Company's officers and senior management take full responsibility for managing the Company's capital and do so through quarterly meetings and regular review of financial information. The Company's Board of Directors is responsible for overseeing this process.

The Company monitors its capital structure and may make adjustments to it in light of changes in the Company's operating performance, changes in economic conditions and the risk characteristics of the underlying assets. When adjustments to the capital structure are considered appropriate, such changes may include the issuance of new shares, issuance of new debt, or re-purchasing of shares for cancellation.

The Company is not subject to externally imposed capital requirements and there has been no change with respect to the overall capital risk management strategy during the period ended September 30, 2022. The method used by the Company to manage its capital has been the issuance of new share capital. Management does not foresee any changes to this in the future, however this cannot be assured.

#### Credit risk

Credit risk is the risk of an unexpected loss if a customer or third party to a financial instrument fails to meet its contractual obligations and arises principally from the Company's cash and cash equivalents and government contribution receivable. At present, the Company holds its cash in Canadian rated financial institutions and will only consider investment of excess cash in highly rated government and corporate debt securities or guaranteed certificates from Canadian chartered banks. The Company has established guidelines, including diversification, credit ratings and maturities, to ensure safety and liquidity of its cash. These guidelines are periodically reviewed by the Company's audit committee and modified to reflect changes in market conditions.

### Liquidity risk

Liquidity risk is the risk that the Company will not be able to meet its financial obligations as they come due. To the extent that the Company does not believe it has sufficient liquidity to meet its current obligations, the Board of Directors considers securing additional funds through issuances of equity and debt or partnering transactions. The Board of Directors approves the Company's annual operating and capital budgets as well as any material transactions outside the ordinary course of business. Management regularly reviews these budgets and maintains short-term cash flow forecasts. At September 30, 2022, the Company's current liabilities including accounts payable and due to related parties were \$63,093 (December 31, 2021 - \$92,014).

### Market risk

Market risk is the risk that changes in foreign exchange rates, interest rates and equity prices will affect the Company's future cash flows or valuation of its financial instruments. The Company is exposed to the financial risk related to the fluctuation of foreign exchange rates. Foreign currency risk is limited to the portion of the Company's business transactions denominated in currencies other than the Canadian dollar, primarily expenses for consulting, research and development work incurred in US dollars. The Company believes that the results of operations and cash flows would be affected by a sudden change in foreign exchange rates, but would not impair or enhance its ability to pay its US dollar denominated obligations. The Company does not currently view its exposure to US dollars as a significant risk due to the limited volume of transactions it conducts in this currency.

The Company is subject to interest rate risk on its cash and cash equivalents and believes its results of operations, financial position and cash flows would not be significantly affected by a sudden change in market interest rates relative to the investment interest rates due to the short-term nature of the investments. Excess cash is invested in highly rated investment securities at fixed interest rates with varying terms to maturity but generally with maturities of nine months or less from the date of purchase.

As at September 30, 2022, the Company held no cash equivalents. The Company does not invest in equity instruments of other corporations.

Changes in the Company's share price could impact its ability to raise additional capital.

### Fair value hierarchy

Financial instruments recognized at fair value on a recurring basis in the consolidated statement of financial position must be classified into one of the three following fair value hierarchy levels:

Level 1 – measurement based on quoted prices (unadjusted) observed in active markets for identical assets and liabilities;

Level 2 – measurement based on inputs other than quoted prices included in Level 1, that are observable for the asset and liability;

Level 3 – measurement based on inputs that are not observable (supported by little or no market activity) for the asset or liability.

## INTERNAL CONTROLS OVER FINANCIAL REPORTING

### Changes in Internal Control over Financial Reporting (“ICFR”)

In connection with National Instrument 52-109, Certification of Disclosure in Issuer’s Annual and Interim Filings (“NI 52-109”) adopted in December 2008 by each of the securities commissions across Canada, the Chief Executive Officer and Chief Financial Officer of the Company will file a Venture Issuer Basic Certificate with respect to financial information contained in the unaudited interim consolidated financial statements and the audited annual consolidated financial statements and respective accompanying Management’s Discussion and Analysis. The Venture Issue Basic Certification does not include representations relating to the establishment and maintenance of disclosure controls and procedures and internal control over financial reporting, as defined in NI 52-109.

## RISKS AND UNCERTAINTIES

Prospects for companies in the technology development and commercialization sector generally may be regarded as uncertain given the nature of the industry and, accordingly, investments in such companies should be regarded as highly speculative. Readers should carefully consider the risk factors and other information included herein. The risks and uncertainties described herein are not the only ones applicable. Additional risks and uncertainties not presently known to MBITI or currently deemed immaterial may also impair the financial results of MBITI. If any of the risks referred to herein or incorporated by reference herein actually occur, MBITI’s business, financial condition or results of operations could be materially adversely affected.

***MBITI’s near-term financial success and the market price of the common shares will depend upon successful commercialization of one or more the products its licensed products, and MBITI will need to generate sufficient revenues from this to achieve profitability.***

For the foreseeable future, MBITI expects to derive substantially all of its revenues, if any, from the commercialization of one or more of the products it intends to license. There can be no assurances that the commercialization will happen within an acceptable time period, if at all. If MBITI is unable to successfully commercialize the products, MBITI’s future licensing revenues and ability to achieve profitability will be impaired, and the market price of the common shares could decline significantly.

***MBITI may take longer than expected to achieve successful commercialization of the licensed products and at within such time that MBITI expects, if at all.***

Successful commercialization of the products will depend upon securing a partnership with a company or organization who can leverage their commercial experience and infrastructure relating to sales and marketing. This may take longer than expected to and such partnership may not result in the benefits that MBITI expects, if at all.

***Should a potential partner commercialize one or more of the licensed products, they may not gain acceptance within the marketplace, this could have a material impact on MBITI's licensing revenues and business.***

If the products fail to gain market acceptance, MBITI's ability to generate licensing revenue would be impaired, which could have a material impact on its business, financial condition and operations.

***Fluctuations in exchange rates could result in foreign currency exchange losses.***

Substantially all of MBITI's expenses are currently denominated in Canadian dollars, while a portion of its expenses are denominated in foreign currencies, primarily in U.S. dollars. Fluctuations in exchange rates, particularly those involving the U.S. dollar, may affect MBITI's costs. Where MBITI's operations conducted in Canadian dollars are reported in U.S. dollars, such fluctuations could result in changes in reported results which do not reflect changes in the underlying operations. As substantially all of its current expenses are denominated in Canadian dollars, any potential future appreciation of the Canadian dollar against the U.S. dollar could adversely affect MBITI's results of operations. The fluctuation of foreign exchange rate affects the value of these monetary assets and liabilities denominated in U.S. dollars. Generally, an appreciation of the Canadian dollar against the U.S. dollar results in a foreign exchange loss for monetary assets denominated in U.S. dollars, and a foreign exchange gain for monetary liabilities denominated in U.S. dollars. On the contrary, a devaluation of the Canadian dollar against the U.S. dollar results in a foreign exchange gain for monetary assets denominated in U.S. dollars and a foreign exchange loss for monetary liabilities denominated in U.S. dollars. MBITI has not entered into any hedging transactions to reduce its exposure to foreign currency exchange risk. While MBITI may decide to enter into hedging transactions in the future, the availability and effectiveness of these hedges may be limited and it may not be able to successfully hedge all or part of its exposure or at all.

***MBITI's common shares have historically been thinly traded and shareholders may be unable to sell at or near ask prices or at all if they desire to liquidate their shares.***

MBITI's common shares are currently listed on the TSX Venture Exchange and have historically been "thinly-traded", meaning that the number of persons interested in purchasing its common shares at or near bid prices at any given time may be relatively small. This situation is attributable to a number of factors, including the fact that MBITI is currently a pre-revenue-stage company which is relatively unknown to stock analysts, stock brokers, institutional investors and others in the investment community that generate or influence sales volume, and that even if MBITI came to the attention of such persons, they tend to be risk-averse and would be reluctant to follow a pre-revenue-stage company such as MBITI or purchase or recommend the purchase of MBITI's common shares until such time as it generates revenue. As a consequence, there may be periods of several days or more when trading activity in MBITI's common shares is minimal, as compared to a seasoned issuer that has a large and steady volume of trading activity that will generally support continuous sales without an adverse effect on share price. MBITI cannot give assurances that a broader or more active public trading market for our common shares will develop or be sustained. As a result, shareholders may be unable to sell their common shares at or above their purchase price if at all, which may result in substantial losses to them.

## **SHAREHOLDER'S EQUITY AND OUTSTANDING SHARE DATA**

The authorized share capital of MBITI consists of an unlimited number of common shares. MBITI had outstanding common shares, stock options, and warrants (exercise prices, which are in Canadian dollars, have been converted to U.S. dollars at the September 30, 2022 rate of U.S. \$1.00 = C\$1.3707).

On December 19, 2017, the Company effected a previously approved one-for-ten consolidation of all its issued and outstanding common shares. All share and per-share data presented in the Company's

consolidated financial statements and notes have been retrospectively restated to reflect the share consolidation unless otherwise noted. The exercise price and number of common shares issuable pursuant to all outstanding stock options and warrants have been adjusted in accordance with the consolidation ratio.

On June 12, 2019, the Company completed a non-brokered private placement for 4,500,000 units (“Units”) at \$0.05 per Unit for gross cash proceeds of \$169,135 (\$225,000 CDN). Each Unit consists of one common share and one transferrable common share purchase warrant. Each warrant will entitle the holder to purchase an additional share at a price of \$0.05 for a five-year term. The Company incurred share issuance costs of \$4,903 (CAD\$6,523).

On January 7, 2021, there was a private placement by Weir-Jones Engineering Consultants Ltd. (related party) for \$78,700 (\$100,000 CAD) at \$0.05/share for the equivalent of 2,000,000 shares.

On February 14, 2022, there was a private placement by Weir-Jones Engineering Consultants Ltd. (related party) in exchange for the settlement of debt in the amount of \$78,510 (\$100,000 CAD) at \$0.05/share for the equivalent of 2,000,000 shares.
